What data do we collect?

Choose Your Meta LLC and its affiliates/subsidiaries (MetaBoy NFT) collect the following data:

- Wallet Addresses
- Discord Usernames
- Social Media Usernames (Contest Participants)
- Aggregate Google Analytics Information - Geographic & Browser Information
- Demographic Information (Inclusion Surveys)

How do we collect your data?

You directly provide MetaBoy NFT with most of the data we collect. We collect data and process data when you:

- Participate in our Discord
- Participate in a contest
- Use or view our website
- Fill out one of our demographic surveys

How will we use your data?

MetaBoy NFT collects your data so that we can:

- Process your support requests and interact with you via Discord or social media
- Administer Contests
- Evaluate fulfillment of inclusion goals

How do we store your data?

MetaBoy NFT securely stores your data on cloud-based servers.

MetaBoy NFT will keep all data collected in perpetuity. Data may be deleted upon request as specified in this Privacy Policy.

What are your data protection rights?

MetaBoy NFT Privacy Policy

MetaBoy NFT would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request MetaBoy NFT for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that MetaBoy NFT correct any information you believe is inaccurate. You also have the right to request MetaBoy NFT to complete the information you believe is incomplete.

The right to erasure – You have the right to request that MetaBoy NFT erase your personal data.

The right to restrict processing – You have the right to request that MetaBoy NFT restrict the processing of your personal data.

The right to object to processing – You have the right to object to MetaBoy NFT's processing of your personal data.

The right to data portability – You have the right to request that MetaBoy NFT transfer the data that we have collected to another organization, or directly to you, to the extent feasible.
